January 27, 2015 - Meeting Minutes

A regular meeting of the Freeport City Council was convened at 7:00pm by Mayor Rodney Atkinson with Councilmembers Mike Eveslage, Ken Goebel, Tim Hennen and Ben Eittle present.

Swearing-In of Council Member Mike Eveslage

Schirmer administered the Oath of Office to Eveslage.

Approve Agenda

T. Hennen asked that items ‘ j. Resolution Approving 2014 Zoning Permits,’ ‘m. Clerk-Treasurer Report,’ and ‘n. Claim 1708-1754’ be moved to New Business.

Consent Agenda

T. Hennen Moved and Goebel seconded a motion to approve the consent agenda, which includes: December 16, 2014 Special Meeting Minutes, December 29, 2014 Special Meeting Minutes, January 7, 2015 Special Meeting Minutes, January 13, 2015 Special Meeting Minutes, January 13, 2015 Emergency Meeting Minutes, January 14, 2015 Special Meeting Minutes, Resolution 2015-01 Appointment of City Council Member, Resolution 2015-02 Freeport State Bank as Official Depository, Resolution 2015-03 Central MN Credit Union as Official Depository, Resolution 2015-04 Approval of 2014 Donations Received, and Schedule Annual Area Fire Service Association Meeting for February 24th at 8pm . Motion carried 5-0.

Old Business

Waiving of Meeting Fees

Schirmer said city code states council member pay and if council wants to waive pay the city code would need to be changed. Atkinson said the city should get a legal opinion. Schirmer said if meeting pay is a concern, then special meetings should not be called. Schirmer said the city council can change city code or council members can accept the pay then donate it back to the city if they want to.

T. Hennen moved and Eveslage seconded a motion to change city code. Motion carried 4-0 (Goebel abstained).

Atkinson said, “There’s reason for fees and if we were so to make a habit of waiving fees, it sort of becomes discriminatory or difficult. Let’s just use the extreme scenario, every meeting we waive the fee, there’s

probably, myself included, that want a little scratch out of this deal and we'll sit over there and talk with Debbie, I like that. I think the motion should include the language that requires a 100% vote in the affirmative, not a simple majority. I think it can get out of hand."

Goebel said he supports changing city code to require unanimous approval.

Atkinson began using chewing tobacco. Schirmer asked Atkinson to call a recess so that he could speak with him individually. Atkinson told Schirmer to go ahead and talk. Schirmer told Atkinson that city hall is a tobacco-free workplace. Atkinson said that's for employees. Schirmer said it's for the building. Goebel said city hall is a tobacco-free place. Atkinson asked when that happened. Schirmer said 2009. Atkinson disregarded and continued the meeting while using chewing tobacco.

Atkinson asked Schirmer to read back the previous motion. Schirmer read the motion back. Atkinson called for a vote and said he was in favor. Schirmer said a vote had already been taken. Atkinson asked if it passed. Schirmer said yes. Atkinson asked, "What is being talked about then, let's go to the next line." Atkinson asked where they were at now on the agenda.

New Business

2015 Appointments

Atkinson said he thought the Mayor, by statute, had to be the weed inspector. Schirmer said yes, unless somebody else is appointed. Atkinson said he thought it was mandatory

Goebel said he is interested in serving on the EDA.

Atkinson said the city should find out what the EDA situation is. Atkinson asked T. Hennen, "What's the latest and greatest." T. Hennen said he wanted to present city council members with EDA findings. Schirmer asked if he had received the email sent to Atkinson regarding the issue. T. Hennen said no. T. Hennen presented a printout of state statute 469.0195 regarding EDA bylaws and read from the printout. T. Hennen then read from the original EDA bylaws and said they match-up to the state statute pretty good. T. Hennen said in the new EDA bylaws, "the word Mayor is totally out of it and it's a five person board with one member being from the city council; sort of wrong, my opinion."

Schirmer said information was emailed to Atkinson earlier in the month. Schirmer said he asked the Office of the State Advisor (OSA) if the state statute pertains only to enabling of an EDA, and if after enabled, the EDA can make changes. The OSA suggested getting an opinion from the League of MN Cities.

T. Hennen said to Schirmer, "Are you trying to talk me into that the EDA came up with this?"

Schirmer said the bylaws came to the city council and council could have rejected those proposed changes.

Eveslage asked how the EDA came-up with the bylaw changes. Schirmer said EDA members wanted to make the board more appealing to serve on. Eveslage asked if the bylaws could be reverted back to the previous version. Schirmer said yes and that the EDA will be reviewing the bylaws, the state statute and comments.

Atkinson asked if the necessary information was in Chapter 15 of the League of Minnesota Cities handbook. Schirmer said the League of Minnesota Cities handbook is not a legal opinion. Schirmer said the EDA probably made a mistake, and mistakes happen. Schirmer said if the city does not want to make an appointment at this time, that's okay.

T. Hennen said, "I find it ironic that a guy at the lumber yard has to find this stuff out." Schirmer said the EDA has not met yet.

Atkinson said the problem with that logic is that you're throwing the LMC handbook out since it's just an opinion. Atkinson said he's just baffled.

Schirmer said Atkinson was one of the council members that approved the bylaws.

Atkinson said, "I reserve the right to reconsider the motion."

Atkinson said he would like to use only Dymoke Law Office for Legal Advisor.

Atkinson said he talked with Joe Hennen regarding Park and Recreation Commissioner and trying to develop a skating rink. Atkinson said Joe Hennen was okay with naming Dan Austing as a Park and Recreation Commissioner as well. Ertle asked Atkinson if he had spoken with Austing. Atkinson said he spoke with Austing a little bit. Atkinson said it's worth a try since there's nothing for kids to do. Goebel moved and Ertle seconded a motion to appoint Joe Hennen and Dan Austing Co-Commissioners. Atkinson asked if everybody was okay with CentraCare Clinic. Schirmer said there is a motion on the table. Goebel explained to Atkinson that the motion would be to appoint Joe Hennen and Danny Austing as Co-Park and Recreation Commissioners. Atkinson called for a vote. Motion carried 5-0.

~~Atkinson said, "I think the Beacon pretty well paid the price to be here," referring to the city official newspaper.~~ 2/24/15 city council approved deletion

T. Hennen said it would be a great idea to have the Acting Emergency Management Director be the Fire Department First Officer.

Atkinson asked what the Lake Wobegon Trails Association is. Schirmer said in 2014, council appointed him to the LWTA Board as Cliff Borgerding is phasing himself out. Atkinson asked if a Chamber of Commerce member would be better. Schirmer said Borgerding asked the Chamber in 2014, but received no response.

Atkinson asked to skip EDA Appointment, Lake Wobegon Trails Association, and Wellhead Protection Committee, and add Dan Austing to Park and Recreation Commissioner and putting the Acting Emergency Management Director as the First Officer. Schirmer asked if there was a motion. Atkinson said to Goebel, "Make that motion so we can get this done." Ertle asked if Atkinson still wanted to change the Legal Advisor. Atkinson said yes and asked about changing the Legal Prosecutor as well. T. Hennen said he was at a recent Stearns County Municipal League meeting and Janelle Kendal, Stearns County Attorney, was there saying the county was doing more legal prosecuting for cities.

Atkinson said Bob Pottratz is a go-for-the-jugular kind of guy and that someone local is easier to meet with. Atkinson said since Bob Pottratz lost the City of Melrose he may want to work for Freeport. The city council directed Schirmer to ask Bob Pottratz if he would want to be the City Prosecutor.

Atkinson said, "We'll leave Legal Prosecutor, EDA Representative, Lake Wobegon Trails, and Wellhead Protection until a later date," and said that was his motion. Ertle seconded. Motion carried 5-0.

Ehlers & Associates Continuing Disclosure Engagement

T. Hennen asked for someone to explain in simpler terms. Schirmer said Ehlers files annual reports on the city's bonds. T. Hennen asked if the accountant or auditor can do this. Schirmer said he can ask around for comparable prices. Atkinson asked Schirmer to ask Schlenner and Wenner if they provide the same service.

Eveslage moved and T. Hennen seconded a motion to table discussion to obtain comparable prices and simplified language. Motion carried 5-0.

City Council Photographs

Ettle asked if personal pictures could be submitted to Weber Printing instead of having Weber take their pictures. Schirmer said he can ask Weber Printing.

T. Hennen asked if either Weber Printing or ALee Photography is a member of the Chamber of Commerce. Schirmer said he knows ALee is a member; however, he is not sure if Weber is.

Goebel suggested negotiating with ALee by offering the opportunity to advertise in city hall. Schirmer asked what price is acceptable. Goebel suggested \$350 in ex-change for some advertising. Ettle said he was okay with that. T. Hennen said to get the best she can do. Ettle said to just ask her if she can do any better. Schirmer said council should have a motion authorizing the Clerk to accept the estimate from ALee Photography for a set amount. Goebel said \$375. Ettle said \$400 and includes an advertisement. T. Hennen moved to have ALee do it.

Ramacher said, "just a while ago council decided the previous photographs were perfectly fine, and anyone with a digital camera can take a picture that can go on the website." Ramacher said Weber is in advertising and that she works in printing and any digital picture can go on the website.

T. Hennen made a motion that somebody in-house takes charge of this and that he would bring a camera next time. Goebel said his picture has already been taken. Ettle said they can take their own pictures.

A. Hennen suggested that the city council just deal with getting their pictures on the website and deal with printing 8"x10" photos later. Ettle moved and T. Hennen seconded a motion to have Weber Printing take new council member pictures for the website. Motion carried 5-0.

Public Finance Seminar

Ettle asked Schirmer if attending the seminar will help with continuing disclosure reporting. Schirmer said a session regarding continuing disclosure is being offered. Ettle said the cost of sending Schirmer to the seminar may be worth him learning how to do continuing disclosure reporting. Goebel moved and Ettle seconded a motion to approve Schirmer attending the Public Finance Seminar by Ehlers on 2/5 and 2/6.

Deobligation of USDA Grant Funds

Atkinson asked if there was anything the city could purchase with the remaining grant funds, before deobligating. Atkinson said if council wants to be on the cutting edge. "take the money and use it when they discharge the ponds, we pipe the water all the way up to by Neil Borgerding's and when it travels downstream it soaks into the ground and aquifer." Atkinson said, "I wonder if we could do that for \$100,00, get a shit-pumper, dig the waterline up to wherever, re-discharge it up gradient and let it find its way down." Ettle asked when the deadline is to make a decision to deobligate.

Atkinson asked if his project would cost more than \$100,000. T. Hennen said yes. Atkinson said, "Shit." T. Hennen said it would cost \$100,000 to get land use approvals. T. Hennen asked if the grant funds can be used to make USDA loan payments.

Goebel moved and Eveslage seconded a motion to table discussion and direct Schirmer to ask the City Engineer if there are any other projects the city can spend the money on. Motion carried 5-0.

Request by Al Williams

Atkinson said he thought the open forum was part of every meeting.

Ettle said he learned at the LMC Newly Elected Officials training that holding an open public forum is not required. Ettle said he thinks it would be okay to have it.

Atkinson asked why city code would need to be amended when city council was using open public forum until a year ago. Schirmer said sometimes the city council has not done everything by the book. Schirmer said city code requires people to provide advance notice of their desire to speak.

T. Hennen asked the audience if they would prefer to speak without having an appointment. A resident said it might increase public participation. T. Hennen said it's all about the people. Schirmer said it might be beneficial to ask a previous presiding officer for his opinion. Atkinson said, "Put public form on the agenda from here forward."

Approval of 2014 Zoning Permits

T. Hennen asked why the city council approves zoning permits from the previous year. Schirmer said it was done by council in previous years and that he would research need. Ettle moved and Goebel seconded a motion to table discussion and direct Schirmer to research if city council approval is necessary for 2014 zoning permits. Motion carried 5-0.

Clerk-Treasurer Report

T. Hennen asked council members if they read about the street light wiring and said, "when I read that I got "pissed-off at SEH and Design Electric and I would like to have SEH and Design Electric come here and explain something; this shit's not even paid for yet and we've got to replace wiring."

Worms said council decided not to spend the money on doing it. Goebel said he remembers that and said T. Hennen was on city council at the time of that decision. T. Hennen said he does not remember anybody mentioning costs, and "all it would have taken was one of those vendors to mention that in ten years we'd be replacing wiring." Worms said the Engineer, Jim, is no longer at SEH.

T. Hennen said, "Jim and Paul Hetland came to my office and sat their until I caved because they thought Tim Hennen should have another water shut-off stubbed into the property, and they gave me a list of reasons you could not image; finally I said, if we need a water shut-off, put the damn thing in, I don't give a shit, as long as I don't have to cut around it. That phrase cost me \$2,500 on top of a \$46,000 assessment, that pissed me off." Schirmer said he would contact SEH for more information.

Claim 1708 – 1758

T. Hennen questioned claim 1732 and asked how obligated the city is to pay the city attorney and questioned how city council members directed the clerk to contact the city attorney.

Schirmer said the employment agreement review was initiated by K. Goebel and previous council members Ritter and C. Goebel.

Eveslage questioned council members giving direction outside of a city council meeting. Eveslage said he has a big problem with closed-door meetings. Eveslage said decisions should be made at a city council meeting. Schirmer said that ties back to the open meeting law and the outside meeting of Atkinson, T. Hennen and Ettle. Ettle said he attended training on open meeting law and seated officials. Atkinson asked Ettle to repeat the word seated. Schirmer said the word seated was reviewed in regards to the private meeting of Atkinson, T. Hennen and Ettle and that the meeting flies in the face of the open meeting law.

Eveslage said business should be done at a city council meeting. Schirmer said there was a recent time when Eveslage was in his office and he asked Eveslage if he should contact the city attorney or not and Eveslage said no, and that it could wait. Schirmer said that is an example that council members can say no. T. Hennen said, "I make a motion, in-lieu of all the racked-up attorney bills, that the City clerk visits with attorneys after the city council made the motion to have him do it, here." Eveslage seconded. Motion carried 4-0 (Goebel abstained).

T. Hennen said Claim 1753 is something he wants to deal with here. T. Hennen said, "I know when this was done, I came out of church on December 28th and there was a big truck in the middle of the road truck jetting sewer. I think we need city maintenance, since we have 2 full-time people, get a list of agenda things down so if we need sewers jetted, we can do it between 8a-5p and not Sunday night. And with that said I'd like to get something going with city maintenance."

Atkinson said T. Hennen wants to know why we are not doing regular maintenance. T. Hennen said, "I would like to see the city maintenance department sit in this room once so we can discuss this. Are their maintenance schedules, so and so forth?" Schirmer said the LMCIT had approved a no-fault sewer backup insurance policy application that included the sewer maintenance strategy. Ertle asked for a copy of the application.

Ertle asked about cell phones for the maintenance employees. Schirmer said the Public Works Assistant is releasing his phone line from his plan and then it will be added to the city plan. Ertle asked if the city pays for Public Works Director's entire phone and if it is used for personal use. Schirmer said it's a mix, since the Public Works Director has to carry the phone 24-7. Ertle asked how much the city is paying for cell phones and asked if it would be cheaper to buy track phones for each employee. Ertle said he would not want to carry two phones around. Atkinson said his employees carry two phones. Ertle asked for research to be done on how many minutes are being used on city business and if the city could buy track phone for each of the employees and still spend less money. Atkinson said the city should find out if the maintenance employees need smart phones to communicate with the SCADA system. Atkinson said he's surprised how little technology the employees in Melrose have on them. Atkinson asked what the minimum is needed to get by. Schirmer said he would research. Ertle moved and T. Hennen seconded a motion to approve Clerk-Treasurer Report and Claim 1708-1758. Motion carried 5-0.

Ertle asked if a motion is needed to adjourn. Schirmer said the Mayor calls meetings to order and may adjourn them; however, if council wants to adjourn the meeting they can do so by motion.

Atkinson asked what the second page in the agenda additions was, and if he was being asked for his resignation. Schirmer said Goebel expressed disapproval of Atkinson's language and behavior and the page was documentation of Goebel's disapproval. Goebel said 1) Atkinson's uses of inappropriate language is not necessary; 2) Atkinson does not convene meetings on-time; and 3) as a Veteran, he feels disrespected when Atkinson does not remember to recite the Pledge of Allegiance and honor the flag at the start of meetings. Atkinson said, "with all due respect, you are entitled to your opinion but these are the first meetings I've run." Goebel said Atkinson has been on city council two years. Atkinson said, "These are the first meetings I've been running."

Adjourn

Atkinson moved and T. Hennen seconded a motion t to adjourn. Motion carried 5-0. Meeting adjourned at 9:26pm.

Good Day Sir,

I may have missed you for the week, if so, happy Monday when you are reading this.

I did some homework on the lighting design associated with the Main Street project.

From what I understand, in order to save cost, the City agreed to contract with a company (Ameron Inc now) to purchase the concrete polls. In exchange for that purchase, Ameron agreed to do the electrical design for the city. They hired a company out of Fergus Falls (now called Vinco) that did the electrical design for inclusion in the bidding documents. The lighting package was bid with the general construction.

As far as I can tell from the bid tabulation, the majority of the wire installed was an armored cable per the design. Not sure if decisions were made to keep that cable out of conduit as a cost saving measure, or if the design originally didn't include conduit. I also am not sure if that was a standard design feature 10 years ago or perhaps the armored cable was supposed to allow you to avoid the conduit cost. The final quantity installed seems to be close to the quantity bid leading me to believe it was installed per design. Documentation in our files is minimal since we didn't do design, but this is what I was able to piece together.

Along with this memo is Resolution 2014-007 and a copy of a page from Robert's Rules of Order from Rodney.

Mayor Rodney Atkinson requested that Resolution 2014-007 be brought up for rescinding. Along with this memo is an email I sent to Rodney in response, advising him of the potential pitfalls including violation of the city's Code of Conduct.

In 2014 Council Members took a stand against intentionally disruptive and costly actions. You as a city council have the authority to rescind that action.

The recommendation of staff is to not approve Rodney's request. Be advised, there exists the potential for negative publicity upon rescinding of the resolution (e.g. "the new council is sweeping things under the rug and not being transparent") in-turn damaging the city's credibility and public perception.

**A RESOLUTION OF DISAPPROVAL
OF COUNCILMEMBER RODNEY ATKINSON'S PERSONAL CONDUCT**

WHEREAS, the Freeport City Council is aware of emails sent by Councilmember Rodney Atkinson on October 28 & 29 and December 13 & 21 of 2013 to the City Clerk (see Exhibit 'A');

WHEREAS, the City Clerk has expressed concerns to the Council about the emails received from Councilmember Rodney Atkinson;

WHEREAS, the Freeport City Council has determined that Councilmember Rodney Atkinson's emails to the City Clerk were not appropriate, do not reflect the Council's expectation for how Councilmembers should interact with City personnel, have caused preventable expenditures of City funds (see Exhibit 'B'), and resulted in the needless wasting of the Council's and City personnel's time (see Exhibit 'C');

WHEREAS, Councilmember Rodney Atkinson refuses to turn off his personal cell phone during council meetings despite being requested to do so by the Mayor;

WHEREAS, use of a personal cell phone during Council meetings is a distraction and demonstrates a lack of respect for meeting decorum;

WHEREAS, the Freeport City Council holds itself and its Councilmembers to a higher personal standard than ordinary citizens;

WHEREAS, the personal conduct of Councilmember Rodney Atkinson described above, is unbecoming of an elected official in the City of Freeport and is below the Council's high standard of personal conduct that it expects from its Councilmembers.

NOW, THEREFORE, based upon the recitals above, the Freeport City Council hereby adopts this resolution as a written expression of the Council's disapproval of Councilmember Rodney Atkinson's personal conduct while interacting with staff and present at council meetings.

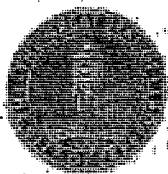

Mason,

Hopefully our discussion this morning was helpful. Here's a recap of what we discussed.

It is ok for council members to discuss properties and their owners by name at a council meeting. You will prepare a short memo for the council to frame the discussion regarding the issue Mr. Atkinson asked to add to the agenda. With respect to Member Atkinson's concerns, it is appropriate for him to discuss building permit issues spurred by the actions of his neighbor, but if he crosses the line and proceeds to act with malice or personal animosity towards the neighbor he likely can no longer be impartial and neutral and has a conflict of interest.

Given Mr. Atkinson's prior comments, we discussed a few hypotheticals. The council should stop the discussion if Mr. Atkinson begins a personal attack on his neighbor or they should ask that Mr. Atkinson not proceed further from the council table as a council member with respect to this issue due to a conflict. However, there is no way to force Mr. Atkinson to recuse himself other than peer and citizen pressure. To the extent that Mr. Atkinson does not recuse himself and proceeds to push the issue out spite or animosity towards his neighbor, the mayor or council should call him out of order. As we discussed at our special meeting earlier this week, the council has a couple tools in the event things get out of control. Someone can move to end debate or discussion and move on to the next agenda item; someone can move to take a short recess; or someone could move to adjourn the meeting altogether. If things do get ugly; the council should do whatever it takes to stop things and make it clear that the council does not condone the use of a member's elected official position to further a personal dispute.
