

During the period from April 18, 2017 through May 23, 2017, we have given significant attention to the following projects on behalf of the City of Freeport:

• Rural Service District

Reviewed state statute and city ordinance governing Rural Service Districts and identified existing Rural Service Districts in Freeport. Prepared and forwarded summary of the effect of Rural Service District ordinance on property tax collections to City Clerk.

• <u>City Contracts</u>

Reviewed notice from State Auditor stating that certain contracts with City Officials did not comply with state requirements. Reviewed state statutes governing contracts with City Officials and forwarded recommendations for bringing contracts into compliance to City Clerk.

Zoning Regulations

Reviewed request to construct garage with second floor apartment. Reviewed zoning regulations, prepared and forwarded opinion to City Clerk that Freeport's zoning regulations do not permit garages with a second floor apartment in R-1 District.

Re: Easement/Lift Station Behind Sacred Heart School



Re: Water & Sewer Charges for Services Trends

When the 2017 1st quarter financials were presented at the April 25 Council meeting, it was noted that the Charges for Services revenue for the Water Fund appeared low in comparison to the budget. I compared this year's revenue with the trends over the last several years to see if this year's revenue was low in comparison to previous years.

The spreadsheets appear on the next two pages for the Water Fund and the Sewer Fund.

- The "Bills Paid" column shows the dollar amount the City received to pay utility bills for each month.
- In Accounting, we utilize a 13th period named "Audit" to record year-end adjustments. In this case, these year-end adjustments are to record December usage (not billed until January) in the proper year. These year-end adjustments are then reversed in January of the next year.
- Because utility rates have changed over the years, we can't get an accurate comparison by looking at dollars alone. The "Percentage" columns were added because the percentage of revenue received in each month should be relatively similar from year to year, even if dollar amounts are not.
- The "%" column shows the percentage of the year's revenue received in each period.
- The "YTD %" column shows the percentage of the year's revenue received from January through April of each year.
- In the 2017 columns, the percentages are calculated using the annual budgeted revenue for the year since we don't have actual revenue received yet. This way, we can compare apples to apples across all years.
- Bottom line: The percentage of revenue received so far in 2017 is similar to what
 we have received in previous years, especially 2015 and 2016. It looks like we are
 on track to meet our annual budget. We will keep watching this as the year
 progresses.

Re: Rural Service District

Following this memo you will find a copy of the City Code that discusses an established Rural Service District. We were unaware we had this district until Stearns County started questioning some of the parcels that are still included in the district and Dymoke looked into it.

Included are also maps of each of the parcels that are a part of the district. When the district was originally established, it gave the specified parcels a 50% tax break. It is now up to the council how you would like to continue with the district. Alter, add, remove?

There is also a sheet that shows the tax breakdowns for the parcels that are included in the Rural Service District.

505.01 Policy

The city council has reviewed the use of land in the city and has reviewed the current cost of government services offered to the residents and landowners of the city, the current source of funds for those services, and the current approximate relative benefits to urban and rural land in the city from tax support municipal services. The city council has concluded that it would be desirable to establish an urban service district and a rural service district for the purposes of all municipal property taxes except those levied for the payment of debt service on bonds and judgments pursuant to Minnesota Statutes, Section 272.67.

505.03 Districts

Subd.1 Established

An urban service district and a rural service district exist in the city for the purpose of municipal property taxes except those levied for payment of debt bonds and judgments and interest thereon.

Subd.2 Rural Service District

The following parcels of land in the city comprise the rural service district:

- 1 Parcel number 54-32021-00
- 2. Parcel number 54-32028-00
- 3. Parcel number 54-32085-00
- 4. Parcel number 54-32051-00

The City Council finds that the land in the rural service district is un-platted and rural in character and none of it is developed for commercial, industrial, or urban residential purposes. The council also finds that all parcels are greater than the 18 acre minimum size established by the council and are utilized as active agricultural farming operations.

Subd.3 Urban Service District

Land in the city other than that included in rural service district is in the urban service district.

505.05 Tax Capacity District

The parcels of land in the rural service district receive approximately 50% of the benefits resulting from tax supported municipal service as compared to parcels of land of like value in the urban service district. Therefore, the tax capacity rate to be levied upon the rural service district lands will be 50% of urban district mill rate.

505.07 Amendment

This Section may be amended to change the above benefit ratio or to add or remove lands from the rural service district. An amendment is not required to remove lands which are to be developed for commercial, industrial or residential uses in accordance with Minnesota Statutes, Section 272.67, subd.5.

505.09 Application

This Section applies to taxes payable in 1986 and subsequent years subject to amendment as provided by law.
