1. That Subdivision 3 of Section 85.10 (Rental Unit Licensing) of Ordinance No. 85 shall be amended to read as follows:

"Subd. 3: <u>Registration</u>. The registration statement for all rental dwellings shall be filed with the City Clerk no later than February 1st every two years."

The ordinance shall become effective upon publication.
