February 28, 2023 – Meeting Minutes

A regular meeting of the Freeport City Council was convened at 7:00 pm by Mayor Mike Eveslage, and council members Nick Arnzen, Sarah Blake, Tim Hennen, and Jake Renneker.

Staff in attendance: Public Works Director Loren Goebel, City Clerk-Treasurer Jon Nelson, City Financial Advisor Ashley Feldewerd, City Engineer Dave Blommel, City Attorney Scott Dymoke, and Fire Chief Andy Grieve.

AFSA Representatives in attendance: Pete Welle & Tom Roelike, Oak Township; Nate Arnzen, Joe Wiechmann, & Chad VanBeck, Millwood Township; John Arnzen, City of St. Rosa; Jim Cremers, City of St. Anthony; Randy Hartung, Krain Township; Brian Schneider, Albany Township.

Approve Agenda

• With the addition of claims #5315 and 5316, Renneker motioned to approve the agenda, seconded by Arnzen. Motion carried 5-0.

The regular meeting was left open as Mayor Eveslage opened the 2023 AFSA meeting.

AFSA Meeting

- Nelson took roll call. All townships and cities had representatives in attendance.
- Feldewerd presented the budget that she and Chief Grieve created.
- Welle from Oak Township motioned to approve the 2023 AFSA budget, seconded by Schneider from Albany Township. Motion carried 7-0.
- VanBeck motioned to adjourn the meeting, seconded by Welle. Motion carried 7-0.

Public Hearing: Vacation of Easements in Welle Addition

- Mayor Eveslage opened the Public Hearing.
- Blommel explained that the final phase of the Welle Addition has easements that are going to the drainage pond. The easements, if vacated, will be replaced with new ones in close proximity to the current ones during development. Nothing significant will be

- changing and water will not be redirected whatsoever. The hearing is more of a formality than anything so the City doesn't hit any snags while the final Welle Addition is developing.
- Resolution 2023-06 Vacation of Easements in Welle Addition: Renneker motioned to approve Resolution 2023-06, seconded by Hennen. Motion carried 5-0.
- Mayor Eveslage closed the public form and Blommel fielded questions on the new Welle phase in the small conference room for those in attendance who wished to join him.

Public Forum

Public forum closed.

Consent Agenda

• Hennen, under old business, noticed "AFSA" needed to be changed to "ARPA" for streetlight funds. Arnzen motioned to approve the consent agenda with this change, seconded by Hennen. Motion carried 5-0.

Reports

- a. <u>Clerk-Treasurer Report</u> Jon Nelson
 - Paperwork has been finalized with Matt Imdieke for his Industrial Park lot.
 - Met with Jeff & Mitch Howe to establish new inspection rates. Rates are less than those we had with Inspectron.
 - Nelson was contacted by Nature Energy to see if their company would be a good fit for the City of Freeport. Nature Energy is a renewable natural gas company that captures methane gases from organic waste and turns it into renewable natural gas. Jesper Nielsen, VP of Business Development in the US, is coming for a visit to scope out Freeport.
 - The City of Hinckley has a Jacobsen Turfcat for sale that includes sweeper and mower attachments. It was discussed that the machine should be beneficial for the City and if it's not the right fit it should bring the same amount of money, or close to it, if we decide to resell. Arnzen motioned to purchase the Jacobsen Turfcat from the City of Hinckley for the sum of \$6,500.00, seconded by Hennen. Motion carried 5-0.
- b. Fire Dept Report Fire Chief Andy Grieve
 - 4 calls last month.
 - Everyone is invited to go to the fire hall after the meeting for wings.
- c. Public Works Public Works Director Loren Goebel:
 - A tower well went down. Atkinsons checked the pump and it was determined that a
 damaged wire was the issue. Freeport Electric repaired and the well is back up and
 functioning.
- d. Engineer Report City Engineer Dave Blommel:
 - New USDA regulations are giving our Welle bids a bit of trouble, delaying the process a bit.

- We should expect to call for a public hearing for 2021 sewer & street project at the March meeting, with the hearing being held in April.
- e. Attorney Report City Attorney Scott Dymoke:
 - Nothing significant to report.

Old Business

- a. AFSA Funds Streetlights
 - Council discussed different lights they have seen throughout different communities in the area. The City wants to keep a "downtown feel" or "mall effect" with our light fixtures but poles need to be taller.
 - Council requested to receive quotes for 20' poles with our current fixtures retrofitted to LED bulbs.

New Business

- a. 2022 Fourth Quarter Report Ashley Feldewerd
 - Feldewerd presented the 2022 fourth quarter report to Council.
 - Feldewerd presented a comparison for Abdo's cost to process payroll vs. using Abdo Workforce Solutions. Preliminary numbers show that the City could save \$5,630 by using Abdo Workforce Solutions vs. Abdo Financial Solutions.
 - Arnzen motioned to switch to Abdo Workforce Solutions when Abdo Financial Solutions' contract expires, seconded by Renneker. Hennen, Arnzen, Renneker and Eveslage were in favor, Blake was against. Motion carried 4-1.
- b. Xcel Energy Meeting with Brice Held
 - Nelson met with Brice Held, designer for Xcel Energy, about the possibility of cleaning up the look of the power poles in our downtown area.
 - It would be very costly to move our power supply underground. Every business would have to be on board and would have to pay their own way to tap into the supply.
 - The only reasonable option was to lash three of Xcel's lower lines together at a cost of \$2-300 per span. Nelson believes that this would only do so much and that Council should take a look at the lines to envision if the change would be worth the cost.
 - Residents have asked about support poles that Xcel has installed on their properties.
 Nelson asked if support poles could be moved but Held explained that there's really nowhere else for them to go with the proximity of the lines to neighboring buildings.

Re: Clerk-Treasurer Report

- 1. Mayor Eveslage and I attended LMC's City Day on the Hill. There is a lot going on in our state government this year with 2,900+ bills introduced during the session.
 - We met with Senators Westrom & Howe in their office. We were scheduled to meet with Representative Anderson but he was delayed with prior commitments.
 - MN Small Cities is lobbying to increase local government assistance, supporting a \$150 million increase in funds. They are also supporting a \$40 million per year ongoing funding for transportation. Cities under 5,000 are currently the only government unit that does not have ongoing funding for transportation.
 - With the recent rise of property taxes, citizens should be happy to hear that there is also a homestead exclusion increase proposal.
 - An email was sent out saying our bridge project is going to be pushed back from 2026 to 2028 due to funding.

With the rescheduled meeting I will unfortunately not be able to attend as I have a previously scheduled meeting.

Interstate 94 Bridge

The bridge replacement that was scheduled for construction in 2026 has been pushed back to 2028. The revised timetable will give the City more time to evaluate alternatives to a simple replacement. Along with the additional time for review, we will also have more time to explore funding to help pay for any additional costs incurred by the city as a result of the requested changes to the standard bridge design. MnDOT has proposed meeting again this fall to continue the discussions.

2021 Project

Without being able to attend your meeting, I don't want to put the final assessment information in your packets. We will plan review the final assessments at your April meeting for public hearing in May. It would be an option to have a council work session to go over the assessments if you would so desire.

Welle Final

USDA is waiting on guidance from Washington regarding the funds that will be utilized for the 2023 construction. I have been meeting regularly with USDA state engineer and the state director to expedite the bidding. If I have additional information prior to the meeting I will share with Jon.
