# Memo

Re: Timp Public Hearing

Craig Timp, 213 2<sup>nd</sup> Ave NW, is requesting a variance from the City of Freeport to construct an accessory building at 19 feet, 8 inches in height. City Code currently allows 18 feet maximum height of buildings in the R-1 district.

In order to be granted a variance, we must find that the request meets all three factors of the practical difficulties' test.

# Reasonableness

The first factor is that the property owner proposes to use the property in a reasonable manner.

# Uniqueness

The second factor is that the landowner's problem is due to circumstances unique to the property not caused by the landowner.

# **Essential character**

The third factor is that the variance, if granted, will not alter the essential character of the locality. Consider whether or not the resulting structure will be out of scale, out of place, or otherwise inconsistent with the surrounding area.

Here are factors that I find meet the practical difficulties' requirements:

- 1. **Reasonableness**: Timp's request to build an accessory structure is reasonable.
- 2. Uniqueness: Timp's current attached garage was not built large enough to fit his vehicle, creating the need for a larger building. He is also looking to build up instead of out to preserve green space of his property.
- 3. **Essential Character**: The accessory building would not change the essential character of the neighborhood.

Recommendation: Consider approving the variance request.

# ORDINANCE NO. 2025-02

# AN ORDINANCE AMENDING THE FREEPORT CITY CODE OF 1995, CHAPTER V, SECTION 500 ZONING, PLANNING AND LAND USE WITHIN THE CITY OF FREEPORT, MINNESOTA, ADOPTING CANNABIS BUSINESS REQUIREMENTS

# THE CITY COUNCIL OF THE CITY OF FREEPORT, ORDAINS AS FOLLOWS:

**SECTION 1.** The Freeport City Code of 1995, Chapter V, Section 500.06 – Rules and definitions, Subdivision 2 - Definitions, is hereby amended is hereby amended by adding the following:

Definitions of words and phrases contained Minnesota Statutes Chapter 342 are adopted by reference and shall have the same meaning in this ordinance.

**SECTION 2.** The Freeport City Code of 1995, Chapter V, Section 500.23 – A, Agriculture/Rural Residential District, Subdivision 4 – Conditional Uses, is hereby amended by adding the following:

- 7. Cannabis Cultivator.
- 8. Cannabis Transporter.
- 9. Cannabis Delivery Service

**SECTION 3.** The Freeport City Code of 1995, Chapter V, Section 500.29 - C-1, Central and Neighborhood Commercial District, Subdivision 2 - Permitted Uses, is hereby amended by adding the following:

- 10. Cannabis Retailer.
- 11. Lower-Potency Hemp Edible Retailer.

**SECTION 4.** The Freeport City Code of 1995, Chapter V, Section 500.31 – C-2, Community Commercial District, Subdivision 2 – Permitted Uses, is hereby amended by adding the following:

- 10. Cannabis Retailer.
- 11. Lower-Potency Hemp Edible Retailer.

**SECTION 5.** The Freeport City Code of 1995, Chapter V, Section 500.33 – I-1, General Industrial District, Subdivision 4 – Conditional Uses, is hereby amended by adding the following:

- 6. Cannabis Wholesaler.
- 7. Cannabis Transporter.
- 8. Cannabis Testing Facility.

- 9. Cannabis Delivery Service.
- 10. Cannabis Microbusiness.
- 11. Cannabis Mezzobusiness.
- 12. Cannabis Cultivator.
- 13. Cannabis Manufacturer.
- 14. Lower-Potency Hemp Edible Manufacturer.
- 15. Medical Cannabis Combination Business

**SECTION 6.** The Freeport City Code of 1995, Chapter V, Section 500 Zoning, Planning and Land Use within the City of Freeport, Minnesota, is hereby amended by adding the following:

# 500.38 Cannabis Industry Regulations

# Subd. 1 Outdoor Storage and Display

- 1. Outdoor displays are prohibited. Outdoor display is an outdoor arrangement of objects, items, products, or other materials, typically not in a fixed position and capable of rearrangement, designed and used for advertising purposes or identifying a business, product, or service.
- 2. Outdoor storage of goods and hazardous materials is prohibited. Outdoor storage of equipment must be in compliance with this ordinance. Outdoor storage areas shall be limited to the rear or side yards. At no time shall the storage of equipment extend beyond the front building line of the principal structure. Outdoor storage areas shall be fenced and screened in conformance with this ordinance.

# Subd. 2 Operations and Management Plans

- 1. An operations plan addressing air quality, dust management, sound attenuation, and vibration damping shall be submitted for approval.
- 2. An environmental management plan, including a water and sewer management plan addressing the use of water and the treatment of waste on-site, and a storm water and drainage plan addressing the impact of the facility on the environment, shall be submitted for approval.
- 3. A waste disposal plan shall be submitted addressing storage, handling, use, and potential hazards shall be submitted for approval. Solid waste shall be stored, collected, transported, and disposed of in conformity with Federal, State, and local laws.
- 4. A plan for proper ventilation and filtration for odor control, in conformity with Federal, State, and local laws, must be submitted for approval.

# Subd. 3 Setbacks

Cannabis Industries and businesses shall meet the following setbacks as measured in a straight line from the closest point of the property line of the parcel upon which the cannabis industry or business is located, to the property line of the following uses:

- a. 1,000 feet from a school
- b. 500 feet from a daycare

- c. 500 feet from a residential treatment facility
- d. 500 feet from an attraction within a public park that is regularly used by minors, including a public ground or athletic field.

# Subd. 4 Retail Sales

A cannabis business with a license or endorsement authorizing the retail sale of cannabis flower or cannabis products may not sell cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products between 2:00 a.m. and 8:00 a.m. on the days of Monday through Saturday nor between 2:00 a.m. and 10:00 a.m. on Sunday.

# Subd. 5 Licensed Cannabis Events

On site consumption of adult-use cannabis flower, adult-use cannabis products, lower-potency hemp edibles, hemp-derived consumer products, or any combination of those items, at licensed cannabis events is not permitted.

**SECTION 7.** Effective Date. This Ordinance takes effect upon its passage and publication according to law.

Others in attendance: Branden Roering, Rodney Atkinson, Al Williams, Jason Hoeschen, Jim Hemker, & Eric Streed.

#### Approve Agenda

• Nelson added claims #6161-6170. Arnzen motioned to approve the agenda with the addition, seconded by Blake. Motion carried.

#### **TNT Meeting**

• Mayor Eveslage opened the TNT meeting. Atkinson, Streed, & Hemker commented from the public. Mayor Eveslage asked for further comment and after hearing none, closed the TNT meeting.

#### Public Forum

• Mayor Eveslage opened and closed the public forum without comment.

#### **Consent Agenda**

• Hennen motioned to approve the consent agenda, seconded by Renneker. Motion carried.

#### **Reports**

- a. <u>Clerk-Treasurer Report</u> Jon Nelson
  - LMC Elected Officials Training is coming up in Alexandria. Nelson will send details to council members.
  - After discussion, Arnzen motioned to move the January meeting to Monday, January 27 @7pm, seconded by Hennen. Motion carried.

b. Fire Department Report – Fire Chief Andy Grieve

- 4 calls last month; 1 grass fire, 2 medicals, and 1 cancelled mutual aid.
- Had around 86 calls last year, which is pretty normal.
- Grieve requested that Nelson get certified to sign burning permits so that they would be available at City Hall. Nelson agreed to become certified.

- Grieve asked for preapproval to purchase air bags for the fire department in the amount of \$11,600. Eveslage motioned to approve the preapproval request, seconded by Hennen. Motion carried.
- Fire Department elections were held. Grieve was reelected as Chief, Branden Roering was reelected as Assistant Chief #1, Loren Goebel was newly elected as Assistant Chief #2, and Kyle Rademacher was newly elected as Secretary. Hennen motioned to approve the election results, seconded by Blake. Motion carried.

c. <u>Public Works Report</u> – Public Works Director Loren Goebel

- Discharged the ponds.
- Has been busy doing locates in the Welle IV Addition for utility installation.

#### d. <u>Engineer Report</u> – City Engineer Dave Blommel

- Welle utility installation is under way.
- Lift station pumps will be in soon and installation can begin.
- Looking to submit plans in January for CSAH 11 project.
- Previous SEH invoices were put on hold when Blommel was absent from a council meeting. Blommel reviewed the invoices with council and Hennen motioned to approve, seconded by Arnzen. Motion carried.
- There is one pole along CSAH 11 that will be replaced with a shorter pole because it is too close to power lines. Design Electric is expecting to receive the pole sometime in February.

e. <u>Attorney Report</u> – Attorney Scott Dymoke

• Dymoke worked on a cannabis ordinance that will be covered in old business.
